NATIONAL ACADEMY OF HUMAN RESOURCES ANNOUNCES THE CLASS OF 2020

FOUR NEW FELLOWS AND ONE DISTINGUISHED FELLOW ARE INSTALLED

November 5, 2020 – The National Academy of Human Resources (NAHR) installed its twenty-ninth class of Fellows, an honor considered the most prestigious in the field of human resources, on November 5, 2020.

Since its founding in 1992, only 180 individuals have been elected Fellows of the National Academy of Human Resources, and 15 individuals have been further honored as Distinguished Fellows. Additionally, 13 organizations have been inducted as Honored Organizations for their contributions to the HR profession.
